Temporary 300 Gallon Cans — Customers may request a temporary 300 for two (2) weeks of use every three (3) months. The cost is \$17.85 each time it is dumped (which doesn't have to be your regular garbage day). The additional charges will be added to your utility bill. NOTE: This can is just over 3x the size of a residential container (90 gallons).
