Rates are as follows as per Resolution No. 2276, effective 7/1/14:

Landfill Fees	\$15.75 per cubic yard
Haul Fees – charged each time bin is emptied	\$112.65
Rental Fee – daily minimum (1 day)	\$6.50
Rental Fee – weekly rate (2 days to 7 days)	\$15.70
Rental Fee – monthly rate	\$67.65

TERMS:

- 1) **COMPENSATION.** All costs incurred are billed on a net 30 day basis and due payable.
- 2) **DEPOSIT.** Renter agrees to place a deposit equal to one week of rental and one haul fee to the landfill including landfill fees equal to full capacity of bin. A deposit will not be required if the renter is presently and has been a customer of the City-owned utilities for a period of one (1) year with no delinquencies.
- 3) **TERMINATION OF RENTAL.** Renter must notify City when bin service is no longer needed. Rental fees will continue to accrue until the Renter notifies the City of termination of service.
- 4) **CARE OF BIN.** Renter agrees to maintain and keep the bin in good repair. Reasonable wear and tear is excluded. Due to weight- if concrete, dirt, sand or other heavy materials – LOAD NO MORE THAN 1/3 to 1/2 FULL. Any repairs due to damage of the container for such use will be charged to the renter.
- 5) **WASTE NOT ALLOWED.** Effective January 1, 2010 – No tires, hazardous waste, covered electronic devices (monitors and televisions with a viewable area of 4" or more, computer drives and laptop computers) or automotive batteries allowed. .
- 6) **SERVICE NEEDED.** It is the responsibility of the renter to notify the City at 541-938-8270 when the drop box needs serviced.

DO NOT FILL BINS PAST THE TOP RIM OF THE BIN OR YOU MAY BE REQUIRED TO UNLOAD THE WASTE UNTIL IT IS LEVEL WITH THE TOP OF THE RIM AND/OR SUBJECT TO MINIMUM ADDITIONAL CHARGE OF \$25.00. CITY MAY REQUIRE EXCESS WASTE BASED ON CAPACITY AND/OR WEIGHT BE REMOVED BY RENTER IF IN EXCESS OF ALLOWANCE.
